Project Background and approach

The new climate change agreement, agreed in Paris in December 2015, is to be further defined with rules, modalities and procedures by the Conference of Parties. Article 6, which covers markets and non-markets, is an important element in the Agreement, which will need a substantial amount of political and technical decisions to be taken before it can be implemented.

This meeting is part of the project "Implementation of markets and non-markets provisions in the Paris Agreement", which aims to create an informal atmosphere where the main objective is to explore, discover, explain and understand different points of view related to the issues in Article 6 of the Paris Agreement. That is, to understand the options available to define rules, modalities and procedures on Article 6 of the Paris Agreement, as well as the consequences of adopting each option.

What is also very important is to the extent that participants are willing to explain, to understand the different views, and more importantly, WHY these views are held. The discussions will be free and informal. They are generally started with a presentation from ICTSD and launched with reflections from the participating negotiators. Discussions will be held under Chatham House rules (views expressed can be quoted but cannot be attributed to any of the participants). At the end of each meeting we will not produce summaries, but a Reflection Note, with what the Chair took back from the discussions.

Above all, this process is totally separated from the UNFCCC negotiating process. There is no intention, or mandate, to produce any text or negotiate an outcome.

This project is made possible by contributions received from a number of donors including Australia, Canada, Finland, Sweden, Norway, the European Commission, France, Germany, Japan, Switzerland, New Zealand, and the World Bank.

11:45 Presentation of Text of Draft Negotiating Elements on Article 6.2









At SBSTA 47 the co-chairs produced an Informal Note: "Guidance on cooperative approaches referred to in Art 6.2". This note, together with prior submissions by Parties, will be used by the Chair of SBSTA to prepare an informal document containing the draft elements of guidance on cooperative approaches which will be used at SB 48 negotiations.

This session will include a presentation by Peter Zaman (Reed Smith LLP) & Andrei Marcu (ERCST/ICTSD) of a straw man outlining elements of guidance under Article 6.2, building on the informal note and prior submissions by Parties. The paper will have been peer reviewed by a number of prestigious institutions from both developed and developing countries, who follow Article 6 negotiations.

The straw man intends to eliminate duplications, but keep all substantive options, and produce a useful framework for discussion for negotiators in their informal deliberations and preparations leading to SBSTA 48 in Bonn, May 2018.
