#### Project Background and Approach

The new climate change agreement, agreed in Paris in December 2015, is to be further defined with rules, modalities and procedures by the Conference of Parties. Article 6, which covers markets and non-markets, is an important element in the Paris Agreement, which will need a substantial amount of political and technical decisions to be taken before it can be implemented.

This meeting is part of the "Implementation of markets and non-markets provisions in the Paris Agreement" project, which aims to create an informal atmosphere, where the main objective is to explore, discover, explain and understand different points of view related to the issues in Article 6 of the Paris Agreement. That is, to understand the options available to define rules, modalities and procedures on Article 6 of the Paris Agreement, as well as the consequences of adopting each option.

What is also very important is, to the extent that participants are willing to explain, to understand the different views, and more importantly, WHY these views are held. The discussions will be free and informal. They are generally introduced with a presentation from ERCST and launched with reflections from the participating negotiators. Discussions will be held under Chatham House rules (views expressed can be quoted but cannot be attributed to any of the participants). At the end of each meeting we will not produce summaries, but a Reflection Note, with what the Chair took back from the discussions.

Above all, this process is totally separated from the UNFCCC negotiating process. There is no intention, or mandate, to produce any text or negotiate an outcome.

This project is made possible by contributions received from a number of donors including Finland, Sweden, Norway, France, Germany, Japan, Switzerland, New Zealand, Italy, and the World Bank.

#### 9:15 Reflections on Current Developments

#### 9:45 Definition of ITMOs

This panel is intended to discuss one of the more fundamental issues: what is an ITMO? Different versions of the texts forwarded from Katowice will have some elements of the definitions included.

There will be an initial presentation by Andrei Marcu (15 min) followed by reactions from Ian, Duan, Abdelrahman and Sophie (7 min each).

The presentation will be sent one week in advance to all participants. Some of the questions that may be taken up in the presentation include:

- Does it include reductions, avoidance and removals (what types of removals)?
- What is the definition of reduction and avoidance?
- Does it include all metrics?
- Is it a netting of transfers, or is each transfer an ITMO?
- What does "consistent with the NDC of the participating Parties" mean?
- Does it include Art 6.4 units?
- What is the definition of vintage?

The objective is not to validate the presentation and the views expressed in it. On the contrary, it is only to be used as a starting point, and for the purposes of critique. We hope to reach a common understanding of different views and positions.

All interveners are being asked to read the presentation and comment on what they feel is right and wrong in it, and how they see things fitting together. Their interventions are not meant to simply restate positions, but their views and understanding, using the presentation as a starting point.

# 11:30 Flow of tracking ITMOs & performing, reporting, recording and reviewing of corresponding adjustments

# 15:00 Art 6.4: Avoiding the use of emissions reduction by more than one Party

This discussion will start with a presentation by Andrei Marcu on the paper entitled "Possible interpretations of Art 6.4 and corresponding adjustments" (Marcu & Sinha) (attached). This is will be followed by interventions from Luis, Kazu and Anshari.

This has been one of the thorniest issues, and could not be resolved in Katowice. The issue, is also known, depending whom you ask, as I/O NDC; beyond NDC; double counting (and maybe by many other names).

We expect to debate a number of issues, using the paper as a background/target: - Are we referring to "outside" or "beyond" NDC? What is the difference and what is understood by these terms?

- Does the concept apply to 6.4 or also to 6.2?

- What is the double counting towards – inventory or NDC?

It is possible that many will feel that we have debated this enough already. The reality is that there needs to be clarity before the issue can be negotiated, and we currently feel that this is not the case.

It is also possible, and likely, that some, or many, may have very different understanding of the issue and disagree with parts, or the explanation offered in the paper.
