CDM project activities

- CDM activities
 - Investments made by countries
 - CERs only relates to emission reduction
 - Small part of the investments
- CERs Reduce IRR
 - make project feasible
- Old projects have reduced more the temperature increase than new ones
 - There are very few projects activities after the EU deadline (2012)
- Already commited to contracts
- Abandonned
- Not monitoring
 - Only China and Korea are active
- ICAO
 - Start date of projects 2016?
 - Units generated up to 2020?
