- CDM Project Activity and PoA <u>may transition</u> to the mechanism and registered as A6.4 activities subject to
 - (a) The provision of approval by the host Party
 - (b) The compliance with A6.4 rules and relevant requirements by Supervisory Body
- **◆**Transition period is <u>no later than 31 December 2023</u>
- ♦6.4ERs may be issued after 2021

A. Transition of CDM activities

- The provision of approval of the transition by the host Party, by no later than 31 December 2023
- Applying corresponding adjustment consistent with guidance on 6.2.
- Applying the current approved CDM methodology until earlier of the end of its current crediting period or 31 December 2023
- A6.4ERs from transitioned CDM activities may be issued after 31 December 2020.
- After 31 December 2023, applying the methodologies consistent with rules on 6.4
- Small-scale CDM PA and PoA undergo an expedited process.

- 5.(b) Develop provisions for the development and approval of methodologies, validation, registration, monitoring, verification and certification, issuance, renewal, transfer from the mechanism registry, and voluntary cancellation, pursuant to paragraphs 30–58 of the annex;
- 5.(c) In the context of developing and approving new methodologies for the mechanism, review the baseline and monitoring methodologies in use for the clean development mechanism under Article 12 of the Kyoto Protocol and other existing market-based mechanisms with a view to applying them with revisions as appropriate pursuant to chapter V.B of the annex (Methodologies), for the activities under the mechanism established by Article 6, paragraph 4, (hereinafter referred to as Article 6, paragraph 4 actvities) when Parties and authorized public and private entities use them;
