



Article 6 Support Facility Overview



INTRODUCTION

Provides technical, capacity building, and policy development support to ADB's developing member countries to enhance their preparedness to participate in new carbon markets envisaged under the framework of Article 6 of the Paris Agreement.

- Continuation of ADB's engagement with carbon markets
- Began operations on 1 January 2019
- Initial Tenure: 2019 to 2023
- Current Budget: US\$5 million
- Funded by ADB, Govt of Germany, and Swedish Energy Agency
- Open to all DMCs in the Asia and Pacific region
- Currently supporting 7 developing member countries:
 - Bhutan, Indonesia, Mongolia, Pakistan, Philippines, Thailand and Viet Nam (at different stages of progress)
 - Different needs of DMCs, ranging from support to develop national policy/legal framework and MRV for Article 6 implementation to basic capacity-building and pilots

Article 6 Support Facility ADB Roundtable on Article 6



- The Roundtable discussion is part of ADB's efforts to enable its DMCs to contribute to the development and eventually take advantage of new carbon markets under Article 6
- The Roundtable aims to facilitate discussion among architects of new market mechanisms under the Paris Agreement for building deeper understanding of the technical options and key issues for the ongoing international negotiations.
- 3 Roundtables conducted in 2018 to 2019.
- Three (3) Roundtables will be organized for 2020 (Dec) and 2021 (prior to SBSTA and COP26).

This 4-module training program is also being offered to individual DMCs as a national training under each country work plan.







Output 1: Capacity to identify and assess mitigation actions under Article 6 enhanced

Output 2: Capacity to pilot mitigation actions under Article 6 enhanced

Output 3: Capacity to undertake robust accounting and reporting of mitigation outcomes strengthened

Support Gol to implement key infrastructure and systems for MRV and GHG accounting of mitigation actions.

- Capacity building of key policy makers, international negotiators and other relevant stakeholders to enable them to progress the national agenda and contribute to ongoing international negotiations for Article 6.
- Support Mongolia to identify and assess potential mitigation actions to be pursued under Article 6.
- Support Mongolia to develop policy frameworks for the operationalization of new market mechanism(s) under Article 6 including bilateral mechanism(s) such as JCM.


Roadmap for Conducting Article 6 Pilots









