#### Individual phases of preparation of Territorial just transition plan (TJTP)

At the request of MIRDI, the European Commission, through the **Instrument for Structural Reform Support** under DG Reform, has procured an external consultant, **PricewaterhouseCoopers (PwC)**, which assists MIRDI in developing the TJTP. PwC participates in the entire TJTP preparation process, which consists of several phases:

Identification and mapping of relevant stakeholders Analysis and preparation of a report on the process of transformation of Slovakia towards climate neutrality Analysis of the challenges and needs of the regions most affected by the transformation and preparation of the TJTP, which will define the priorities of individual regions

#### Why involving youth?

- Regions are facing serious demographic challenges (negative migration trend, brain drain, ageing).
- The local economies do not create attractive employment opportunities for the young population or for highly skilled workers.
- □ Young generation must become driving force of the transformation their involvement is crucial.

#### Involvement of youth into preparation of TJTP

- The aim is to actively **involve the young generation**, which is the future of these regions, in the **proposal of priorities and needs**. In addition, it is the young people who will bear the greatest impact of the consequences of the transformation and the negative effects of climate change.
- **Continuous process of work with youth** in the preparation and later in the implementation of specific measures and projects (workshops, information seminars, etc.).
- Support for specific projects for young people, for example by providing small grants for young people to support social projects in their local community to improve attractiveness of the region.
