



### TIMELINE AND EXPECTED OUTCOMES

#### First cycle (2022-2023)

- Establishment of the registry:
  - (1) NMA countries' NDCs

- (2) Mapping of international initiatives (finance and means of implementation).

- Development of NMA country, regional and global profiles.
- Matching facility: 1 & 2
- Coordination network of UNFCCC entities.
- Repository on NMA.
- Working groups of good practices.

#### Second cycle (2024-2025)

- Management and administration of the web-based platform.
- Following up of all previous actions included in the first cycle.
  Priorities:
  - Matchmaking 1 & 2.
  - Development of regional and global initiatives to support NMA countries' NDCs (according to country, regional and global profiles).

## SPECIFICATIONS FOR THE UNFCCC WEB-BASED PLATFORM

- REGISTRY OF NEEDS. Voluntary creation of national profiles that identify NMA based NDC actions that require financing, capacity building, technology transfer and/or other means of implementation.
- REGISTRY OF MEANS OF IMPLEMENTATION. Voluntary creation of profiles that identify initiatives, programs and/or projects inside and outside the UNFCCC that seek to provide financing, capacity building, technology transfer and/or other means of implementation.
- DEVELOPING PROFILES (FILTERING AND GROUPING). Identifying NMA actions by country, region and sector to allow for the identification of similar needs and efficient allocation of means of implementation.
- **MATCHING** the needs with the available registered resources.
- COLLECTION OF INFORMATION. Achievement of objectives and providing transparency of implementation flows for future recommendations and lessons learned.
- **REPOSITORY OF INFORMATION** as relevant and as appropriate.
- SUPPORTING COORDINATION NETWORK of UNFCCC entities on NMAs.
