In 2023, the policy framework related to CCUS and carbon removal technologies gained considerable momentum in the European Union thanks to the new legislative proposals developed by the European Commission, such as the Certification Framework for Carbon Removals (CRCF) and the announcement of an 'Industrial Carbon Management' strategy, alongside other pieces of legislation.

In 2024, important developments in these two files are expected, as the ordinary procedure related to the CRCF should come to an end and the Industrial Carbon Management strategy was published. The roundtable will discuss key developments on the two proposals and provide an opportunity to exchange views on how it addresses concerns from stakeholders.

In November 2022, the Commission proposed a Regulation for the Certification Framework for Carbon Removals (CRCF) to set out a voluntary EU-wide framework to certify three types of carbon removals in Europe. It provides a general framework only, while methodologies will be developed through delegated acts with the help of an expert group. As trilogues have ended, this roundtable aims to discuss and analyse the positions of the three institutions on the CRCF proposal and provide a forum for discussion to foreseen the future development.
