- ◆ Guidance on cooperative approaches referred to in Art 6.2 VI. Recording & tracking, A Tracking (para 29)

Each participating Party shall have, or have access to, **a registry for the purpose of tracking** and shall ensure that such registry records, including through unique identifiers, as applicable, authorization, first transfer, transfer, acquisition, use towards NDCs, authorization for use towards other international mitigation purposes, and voluntary cancellation (including for overall mitigation in global emissions, if applicable), and shall have accounts as necessary.



- ◆ **Rules and Guidelines of JCM between Japan and partner countries**
- ✓ Each Government **establishes and maintains a registry** in line with the common specifications for registries, as developed by the Joint Committee; **to ensure the accurate accounting of the issuance, holding, transfer, acquisition, cancellation and retirement of JCM credits.**

Basic functions and processes for tracking

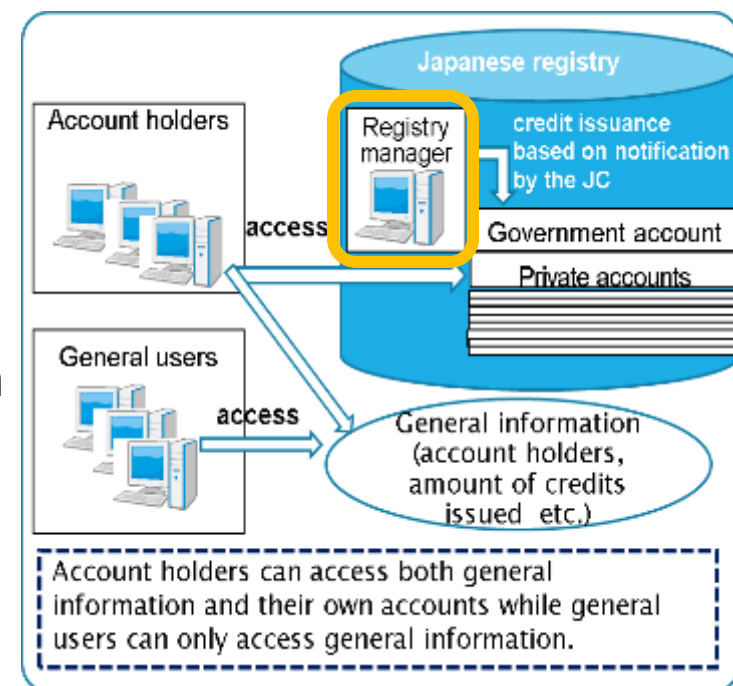

- ◆ Guidance relating to the registries referred to in decision 2/CMA.3, annex, paragraph 29 (para 1& 2)

- ✓ Based on software
- ✓ Accounts for ITMOs, as necessary;
- ✓ Recording the actions relating to ITMOs, including authorization, first transfer, etc.
- ✓ Tracking ITMOs and maintaining records, including through unique identifiers;
- ✓ Providing access to the Party and other entities for which access is authorized by the Party
- ✓ Producing, maintaining and compiling records, information and data, consistently with the annual information submitted in the agreed electronic format



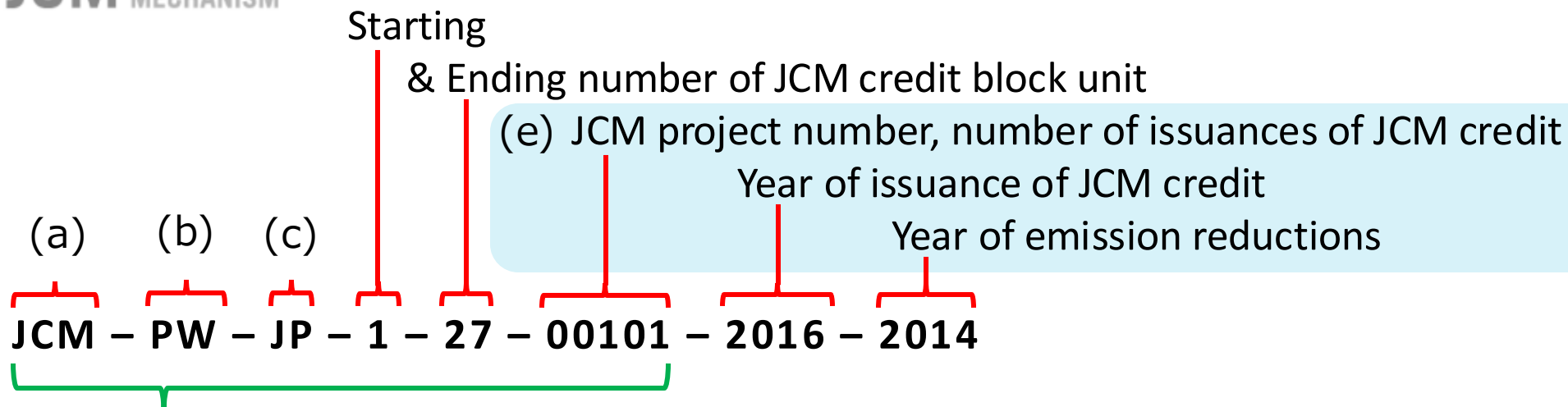
- ◆ **JCM registry of Japan is an electronic registry.**
- ◆ **Common specification of JCM registry**
 - ✓ Accounts for the government, each entity, cancellation and retirement
 - ✓ Establishing and maintaining a transaction record to verify the validity of transactions
 - ✓ Account holders (Governments and entities) can access the registry



Tracking and recording methods

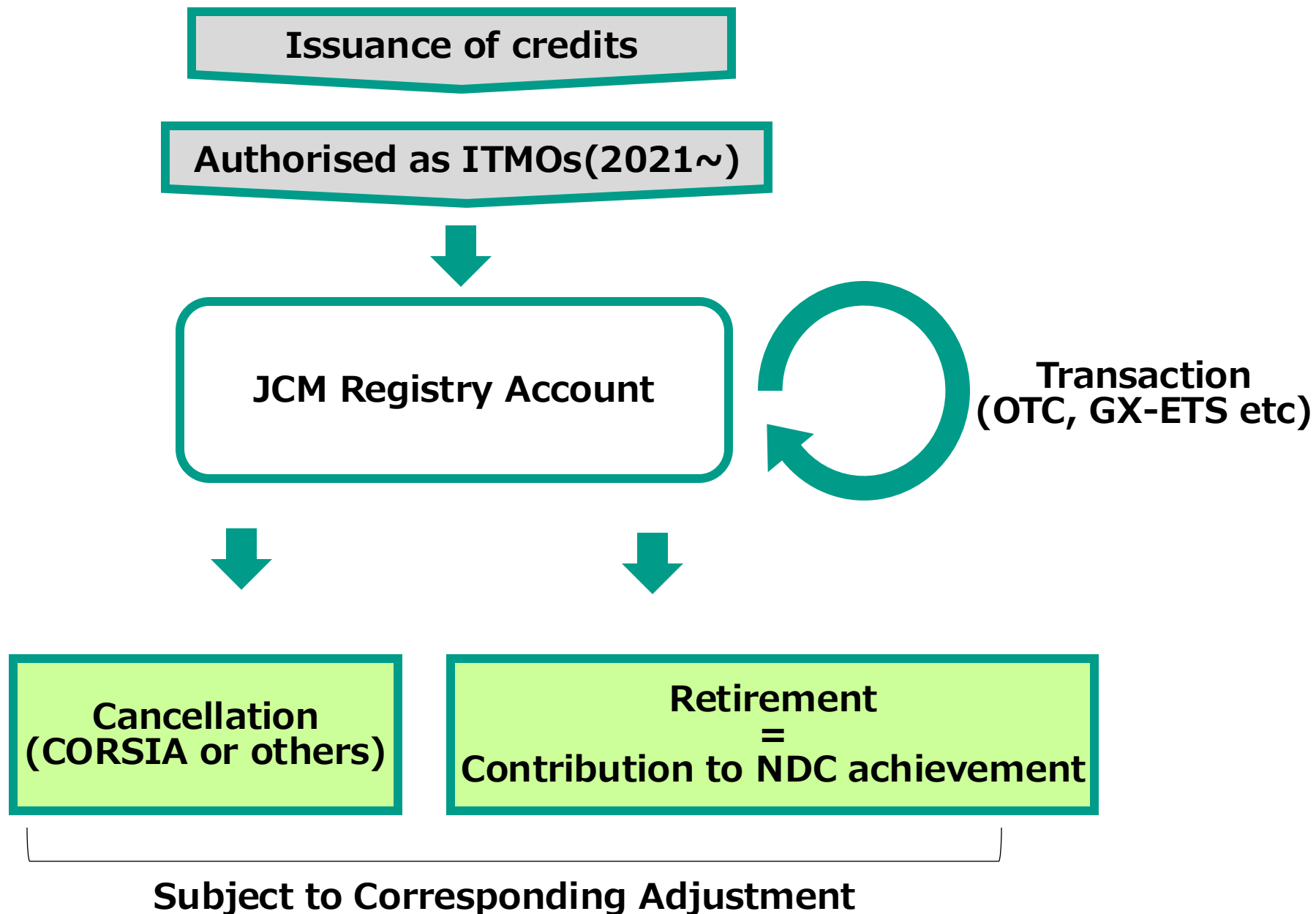
- ◆ Guidance relating to the registries referred to in decision 2/CMA.3, annex, paragraph 29 (para 5 & 6)

- ✓ The unique identifier for each ITMO shall comprise at the minimum:
 - (a) The identifier of the cooperative approach;
 - (b) The identifier of the originating Party registry;
 - (c) The identifier of the first transferring Party;
 - (d) The serial number;
 - (e) The vintage of the underlying mitigation outcome.
- ✓ ITMOs can be tracked and reported in blocks.

- Japan provides JCM registry system for the management of JCM credits in partner countries (Mongolia started to use it in 2022)
- Easier for tracking of JCM credits

Future direction

- Additional function will be developed in the existing system. (Export AEF for annual information)
- No plan to connect with other registry systems, but Japan will participate Article 6 RSA forum to consider several options.
