



# Second Webinar: **Reporting on the Impacts of Response Measures – Ghana Case Study**

This is the second webinar of the project "Reporting on the Impacts of Response Measures – Ghana Case Study" which aims at contributing to Activity 4 of the Katowice Committee of Experts on the Impacts of the Implementation of Response Measures (KCI) by developing a case study for the country of Ghana.

The main objective is to enhance, identify, measure, analyse, and understand the impacts of the implementation of response measures in the jurisdiction, as well as identify measures to address their impacts, while also building capacity among involved stakeholders.

The following are the main steps that will be undertaken in assessing the impacts of international response measures (RM) in Ghana:

**Step 1:** Describe the country and its characteristics

Step 2: Identifying important sectors to the Ghanaian economy

Step 3: Identify sectors potentially vulnerable to international response measures

**Step 4:** Identify relevant response measures

**Step 5:** Assess the impacts of international response measures

**Step 6:** Look at possible domestic and international tools and support which may be needed to address the impacts

The first webinar, which was held in December, focused on outlining the case study deliverables, introducing to stakeholders the topic of response measures under the UNFCCC, describing the methodology that ERCST has developed for the Chilean Case Study and gathering feedback on how the methodology could be better tailored to the Ghanaian context.

This webinar will start with the presentation of process followed and findings for Step 1, 2 and 3 of the methodology outlined above and the data availability challenges encountered on the way.



Building on the previously portrayed data availability challenges, there will be interventions on the common data issues that can be encountered when conducting this kind of studies.

Finally, the intersections and opportunities between this project and the KCI work programme will be examined in-depth.
