


Green Deal Action Plan (16 July 2021)



* Action Plan includes a total of 32 objectives and 81 actions under 9 main headings.




Carbon Border Adjustments



EU's list of sectors and sub-sectors to be at significant risk of carbon leakage covers 63 sectors and sub-sectors

The Commission released its proposal for a carbon border adjustment mechanism under the Fit for 55 package proposal on July 14, 2021.



Main Actions Under «Carbon Border Adjustments»



- ➤ Enabling the recognition of the monitoring system of greenhouse gas emmissions in Turkey and certification according to the EU methodology in Turkey
- ➤ Evaluating the impact of CBAM on Turkish sectors and determining the roadmaps/activities to support and incentivise the reduction of greenhouse gas emissions in sectors of priority that may be subject to a CBAM
- ➤ Determining Turkey's position for an appropriate carbon pricing mechanism and evaluating support mechanisms for increasing costs on sectors
- > Other actions under the headings on green and circular economy, sustainable finance and diplomacy also aim to support action under this heading



Priorities and Actions that will support actions under the CBA heading



Green and

Circular

Economy

- ➤ Initiatives for the improvement of access to international and EU financing facilities for Turkey's green transformation
- Reviewing the National Incentive System
- Strengthening the green finance ecosystem in Turkey (taxonomy legislation, sustainable finance framework, Green Bond Guide and Green Sukuk, sustainable banking)
- Carrying out information and promotion activities for more effective use of existing financing opportunities

➤ Technological infrastructure needed for green transformation will be strengthened and sectoral R&D studies will be supported within the scope of the technology roadmap to be determined together with all stakeholders.



Priorities and Actions that will support actions under the CBA heading



- > Exploring the possibilities of cooperation with the EU and EU member states
- ➤ Continuing efforts to protect Turkey's rights arising from international agreements

- ❖ Technical work should be started immediately in order to ensure that the CBAM is implemented in a way that does not hamper the free movement of goods between the EU and Turkey.
- Turkey's access to Green Deal financing resources is necessary as a candidate country and Customs Union partner.
- ❖ Turkey would like to focus on building partnerships and further development of our commercial and economic integration that would also contribute to EU's green deal agenda.



EU Circular Economy Action Plan and Sustainable Product Initiative

- > make sustainable products the norm in the EU
- empower consumers and public buyers
- focus on the sectors that use most resources and where the potential for circularity
- > ensure less waste





Main Actions Under «Green and Circular Economy» (23 Actions)

- Impact and needs analysis studies for priority sectors regarding circular economy
- Turkey's Circular Economy Action Plan & National Sustainable Consumption and Production Action Plans
- National action plan and implementation timeline for the implementation of EU Integrated Pollution Prevention and Control (IPPC) legislation.
- Development of the National Life Cycle Assessment (LCA) Database and the establishment of a National LCA Platform
- ➤ Green Organised Industrial Zone and Green Industrial Park
- Support R&D studies to strengthen the technological infrastructure
- > Strengthening the regulatory framework in Turkey (EU Sustainable Product Initiative, chemicals legislation, cleaner production legislation in the textile sector and creating cleaner production legislation for the leather sector)
- Dissemination of Turkey's Environmental Label System
- > Sustainable use of water in production and consumption and the reuse of waste water
- Resource efficiency activities carried out by Development Agencies

Green and Circular Economy



Main Actions under «Combating Climate Change» (11 Actions)

- Preparation of Turkey's Report on Combating Climate Change
- Preparation of the 2023-2030 Climate Change Action Plan and the 2050 Climate Change Strategy
- Ratification of the Paris Agreement
- Research on the effects of climate change on biological diversity, ecosystems desertification and land degradation and implementing adaptation and mitigation measures

- > Effective Implementation of the Action Plan with the participation of all stakeholders
- Updating medium and long-term objectives
- > Preparation of comprehensive action plans for achieving a carbon-neutral future
- Increased cooperation and intensified dialogue with the EU at every level

- Access to finance remains key
